From the Interim City Manager, Martin Yamamoto



Dear Residents of Mill Creek,

In early 2020, we experienced one of the most significant events in our history. The Covid-19 pandemic crippled economies and workforces across our country, state, and our great city. On behalf of the City of Mill Creek, I want to thank you for your resilience and patience throughout this pandemic.

During my 18 years as a public servant, I have worked with many leaders across municipal governments and in the public sector. The City of Mill Creek's management team is one of the most productive I have ever worked with, and as our rebuilding continues, I am confident that this team will bring the City to a level of services that sets the standard for local government.

We are currently developing a multi-year plan, focusing on rebuilding our core business. This foundation is necessary to deliver the highest quality service to our residents and communities while planning for the future development of Mill Creek.

This plan will require establishing an optimal workplace where staffing is a priority. We are in the process of filling our budgeted positions while planning for future capacity needs across all departments, including Police, Public Works, Planning, and Administration.



We held an all-staff meeting on April 27, 2022, the first since the start of the pandemic. Our leadership team, including Mayor Brian Holtzclaw and Mayor Pro Tem Stephanie Vignal, were present to connect with employees and update all on recent accomplishments and the City's goals. I look forward to these meetings; they are critical to our communications plan.

On April 26, 2022, our residents voted to annex into South Snohomish County Fire & Rescue Regional Fire Authority (South County Fire). Annexing to South County Fire was the most cost-effective choice considering current data for 2022. Annexation will take effect in August, and property owners will start paying taxes to South County Fire in January of 2023. In the meantime, we will continue to pay Snohomish Regional Fire & Rescue (SRFR) for service until our contract expires on December 31, 2022. We appreciate the high-quality service SRFR has provided the city since 1983. Both SRFR and South County Fire have assured a seamless transition between the agencies. The Mill Creek Fire Station will continue to have the same number of apparatus, firefighters, and paramedics serving the community. We encourage residents



STATE OF THE CITY

Mill Creek is a great place to live and work. My commitment to our residents and communities is that your municipal government will continue to operate in partnership with you as we provide outstanding customer service and an exceptional community experience. It is an honor to serve you.



Q: What are you excited about in 2022?

Brian We are excited to get back to planning for the Dobson, Remillard, Cook, and Church (DRCC) properties. The DRCC includes about 15 acres just north of Freedom Field. (See image below)

Stephanie Having been out in the community, many people have had questions about what the City wants to do with the DRCC property. Last year [the City Council and City Staff met], and we started envisioning the possibilities for this property, something where the whole community could come together. We are excited that we just received funding from the State to work on our site plan for the DRCC and continue moving forward to see [our ideas] become a reality.

Q: Mill Creek is looking for a City Manager. Can you tell us what that process looks like and how it's moving along?

We are working with a search firm and have spread a broad net to look for the right person. Coming out of the pandemic, we have many opportunities to build for the future, and we need the right person to take on this challenge. Our plan is to bring the candidates to Mill Creek to meet with the community, and hold final interviews (this summer.)

Q: What do you see as the primary roles and responsibilities of the City Manager once hired?

B We have a Council-Manager form of government. The City Manager is the Council's one employee, and the City employees technically work for the City Manager and not the Council. We are looking for someone who can work as a partner with the Council to help us implement our vision for the city and the priorities that we identify.

Q: What has Mill Creek learned from the pandemic, and how do you think that will affect your future?

B We have a new normal; we've had to learn how to deliver services differently like passport services, we have had to adjust how we provide this service due to the limitations of gathering in one place. We have moved into a hybrid world of holding public meetings, which I'm excited about because I have seen more people in the Council meetings. I tell people, "this is your government - if you like something we're doing, tell us; if you don't like something we're doing, tell us."

Q: So, what else are you excited about?

especially in 2023 and 2024, is planning for the sub-area, areas south of Mill Creek Town Center to Hwy 527. City Council formed a group including Council members, staff, citizens from our various boards, and property owners to look at what we could do with that area over the next 10-30 years. We have a great opportunity to do some visioning on how we want to see that developed, while also addressing some of our obligations under the Growth Management Act to plan for population growth. This is going to be a community discussion about what we want our city to look like in the next 20 or 30 years.

We started City Chat about a year and a half ago as an open forum and an opportunity for the public to tell us things they think we need to know, what we're doing wrong, and what we're doing right so we don't stop doing it.

We've got a great team here; it's not just the two of us but seven great Council Members, great directors, and great staff to put this all together and keep us moving forward, so I'm excited for what the future holds for Mill Creek.



Pickleball

Pickleball is Washington's Official State Sport.

On March 28, 2022, Gov. Jay Inslee signed Senator John Lovick's Senate Bill 5615 into law on Bainbridge Island, making Pickleball Washington's Official State Sport.

Pickleball is a sport played with a paddle and plastic ball that combines tennis, badminton, and ping-pong elements. The rules are simple, and the game is easy for beginners to learn, but it can develop into a quick, fast-paced, competitive game for experienced players.

The City has cleaned the courts at Heron and Highlands Park sports courts and installed new tennis nets. In addition, Heron Park has been striped for one Pickleball court utilizing the existing tennis net, and Highlands Park has been striped for two Pickleball courts for those that wish to bring their own nets.

The courts are open to the public without reservations and are available year-round from 8 a.m. to 10 p.m. 7 days per week.

Complete Streets Pedestrian Improvements

The 2021 Complete Streets Pedestrian Improvements project constructed pedestrian improvements at three different locations in Mill Creek. We were able to finalize and complete these small but important safety projects last month.



New ADA compliant crosswalk with signage and rectangular rapid flashing beacons (RRFB) on 136th Street SE between the football and baseball fields east of Jackson High School.



New sidewalk on Heatherwood Drive which now connects people to the SWIFT bus stop on Hwy 527 and allows safer travels for Heatherwood Middle School and Jackson High School students.

New Equipment Makes

As Spring is upon us, the public works crew is getting out to trim vegetation, maintain our streets and sidewalks, and spruce up the parks. New equipment is helping the City become better equipped to self-perform some important maintenance functions. The recent acquisition of a new, safer bucket truck, chipper, and arborist box has allowed staff to conquer some overhanging branches and dying tree on Old Seattle Hill Road. A new excavator is going to allow the crew to investigate and repair a couple of small sinkholes that are developing in neighborhood streets. Taking these jobs on directly with our own equipment will help us eliminate the overhead of bidding work and managing contractors where it is easily to just get it done.
